APPOINTMENT OF TEN CONSULTANTS FOR AVIATION SECURITY

Applications are invited from eligible and experienced persons in civil aviation security to serve as Consultants for a period of one year initially on purely short term contract basis at a consolidated remuneration not exceeding Rs.30,000/- per month. Persons who are below 65 years of age including retired government employees and possessing the requisite qualification may submit their applications within **15 days** from the date of publication of this advertisement in the National News Papers.

Essential/Desired qualification

- (i) Graduate from a recognized university,
- (ii) Ten years experience in civil aviation matters, out of which at least five years should be in civil aviation security in a responsible position,
- (iii) Undergone Basic and Advanced Aviation Security course of the BCAS,
- (iv) Undergone National Auditors/Inspectors course of the BCAS,
- (v) Age below 65 years.

The Consultant can be appointed either at Headquarters in New Delhi or any of its existing Regional Offices i.e. Delhi, Mumbai, Chennai, Kolkata or new offices to be opened at Ahmedabad, Guwahati, Amritsar and Hyderabad.

Terms and conditions

- The appointment is purely on a contract basis and any service rendered will not bestow right for regularisation of service or privileges of a government employee
- A consolidated monthly remuneration of Rs.30,000/- only will be paid during the duration of the contract. However, in case of retired Government employees this remuneration shall be subject to the relevant instructions laid down by the government in this regard.
- No other allowances viz. Dearness Allowance, Transport Allowance, Medical reimbursement, LTC etc. is admissible. They will also not be entitled for pension, provident fund or residential accommodation.
- Conveyance charges as admissible under Rules may be allowed.
- Travelling Allowance as entitled for Assistant Commissioner of Security of BCAS for approved tour will be admissible.
- Contract can be renewed by mutual agreement with approval of the competent authority.
- Contract can be terminated by either side by giving one month's notice or payment of one month's consolidated emoluments in lieu thereof.
- Contract can be terminated without notice by the competent authority if at any time, information, past or present, concerning the individual which is

detrimental to national security is received or his activities are found to be damaging to the interests of BCAS.

- They are liable to be posted at any office of BCAS in the country.
