<p><b><u>PROMOTION:</u></b> Senior Aviation Security Officer in Level-7 of Pay Matrix with three years of regular service in the grade and possessing a degree from recognized University.</p> <p>Note: Where Juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.</p> <p><b><u>Deputation(Including Short-Term Contract):</u></b></p> <p>Officers under the Central or State Governments or Union Territories including Central Armed Police Force or Public Sector Undertakings or Recognized Research Institutions or Universities or Semi Government or Statutory or Autonomous organization;</p> <p>(A)(i) holding analogous post on regular basis in the parent cadre/department;</p> <p>or</p> <p>ii) with three years service in the grade rendered after appointment thereto on a regular basis in posts in level 7 or equivalent in the parent cadre or department;</p> <p>and</p> <p>(B) Possessing the following educational qualification &amp;experience:</p> <p>i. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.</p> <p><b>Note 2:</b> -Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.</p> <p><b>Note: 3</b> The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 52 years as on the closing date of receipt of applications.</p> <p><b>Note 4:</b> No absorption of deputationists will be allowed.</p> <p><b>Note 5:</b> Whenever a promotional post is filled up through the mode of 'deputation' by invoking 'failing which' clause, the person so appointed (on deputation basis) will be repatriated once an eligible cadre officer becomes due for promotion against the said promotional post.</p>
