**CIRCULAR**

**Sub: Extension in date of applying for appointment of Consultants in BCAS.**

Reference is invited to the earlier vacancy circular of even no. dated 8<sup>th</sup> August, 2016. The last date of applying for the 10 posts of Consultants in BCAS, that was earlier mentioned as 16<sup>th</sup> September, 2016 on BCAS website, is hereby extended upto 20.11.2016

2. The following amendments are hereby authorized to incorporate in the above mentioned vacancy circular as under:-

**i. FOR (at page 1 of the advertisement)**

The remuneration to be paid to retired government servants will be Last Pay Drawn Minus Pension and those from PSU's will be Last Pay Drawn and the experts other than retired Govt. Servants/ PSUs will be in the range of 20,000-50,000/- per month (all inclusive).

**READ**

“The Maximum remuneration to be paid to retired government servants will be Last Pay drawn + DA – (Basic pension + DR on basic pension) and those from PSU's will be in the range of Rs.20,000/- Rs.50,000/- per month (all inclusive) or Last Pay Drawn, whichever is less.” It is further clarified that remuneration in respect of PSU Employees, to be engaged as Consultants, would be Maximum of Rs. 50,000/- only (Rupees Fifty thousand only).

**ii. FOR (at annexure II of the advertisement)**

The remuneration to be paid to retired government servants will be Last Pay Drawn Minus Pension and those from PSU's will be Last Pay Drawn.

**READ**

“The Maximum remuneration to be paid to retired government servants will be Last Pay drawn + DA – (Basic pension + DR on basic pension) and those from PSU's will be in

the range of Rs.20,000/- Rs.50,000/- per month (all inclusive) or Last Pay Drawn, whichever is less.” It is further clarified that remuneration in respect of PSU Employees, to be engaged as Consultants, would be Maximum of Rs. 50,000/- only (Rupees Fifty thousand only).

3. The applicants are advised to apply for one post only and not for multiple posts.
4. All other Terms & Condition of vacancy circular dated 8<sup>th</sup> August, 2016 will remain unchanged/unaltered.
